**S.O. 3737(E).**—In exercise of the powers conferred by sub-sections (1) and (2) of section 70 of the Information Technology Act, 2000 (21 of 2000), the Central Government hereby makes the following amendments in the notification number S.O. 421(E) dated 1<sup>st</sup> February, 2024 published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii) namely:—

- (i) in paragraph (1), for the words “KFin Technologies Private Limited” at all the places where they occur, the words “KFin Technologies Limited” shall be substituted.

2. This notification shall come into force on the date of its publication in the Official Gazette.
